("Order No.3")

Transport for London ("TfL") as regards Order No. 1 above, the Environment and Transport Committee of London Councils ("TEC") as regards Order No. 2 above, and Heathrow Airport Limited as regards Order No.3 above, (collectively referred to as the "Order Making Authorities") hereby jointly give notice that they intend to make the three above named Orders ("the proposed Orders") under section 6 of the Road Traffic Regulation Act 1984 (as amended) and, in respect of Order No. 3 by Heathrow Airport Limited, additionally under section 124 and Schedule 9 of the Road Traffic Regulation Act 1984, the Aerodrome Traffic (Heathrow) Order 1976 and sections 1, 2 and 65 of the Airports Act 1986.

The general nature and effect of the proposed Orders will be to prohibit goods vehicles exceeding 3.5 tonnes maximum gross weight from being used or driven on roads within the areas affected by the three Orders unless they are fitted with both a Class V mirror (a close proximity exterior mirror) on the passenger side and a Class VI mirror (front mirror) and alos with sideguards as set out in the proposed Orders and subject to exceptions, exemptions and conditions more particularly described in them.

- 2. The proposed Orders will commence on [XXX 2015].
- 3. The roads affected by the proposed Orders are as follows:

Order No 1: GLA Roads and GLA Side Roads

The roads that would be affected by Order No.1 will be all GLA Roads and all GLA Side Roads in Greater London within the boundary of the London Low Emission Zone ("LEZ"). (The area of the LEZ is defined in paragraph 1 (j) of the Schedule to the Greater London Low Emission Zone Charging Order 2006, as amended.)

Order No.2: Borough roads

The roads that would be affected by Order No.2 will be all roads in Greater London within the boundary of the LEZ other than GLA Roads and GLA Side Roads.

Order No. 3: Heathrow Airport

All roads owned by Heathrow Airport Limited at Heathrow Airport, London.
